**FORMAT and RULES:** U.S.T.A. rules and 'The Code' will govern play. Singles – best of three sets with a 10 point match tiebreak in lieu of the third set. Doubles – best of three tiebreak sets. Players must show current U.S.T.A. card or receipt. If you are not a U.S.T.A. member, please join online at usta.com Warm up limited to 10 minutes, serves included. Name of doubles partner must accompany entry. Twelve point tie breaker at six all. Point penalty system will be used for tardiness and behavior. DEFAULT TIME is 15 minutes.

**AGE REGISTRATION GUIDE:**

12 and under	must be 12 until August 1, 2009
14 and under	must be 14 until August 1, 2009
16 and under	must be 16 until August 1, 2009
18 and under	must be 18 until August 1, 2009

**FEES:** \$23 per person/singles; \$30 per team/doubles

**LIMIT:** Two events per person. **NOTE** – Limit one singles event per person. If entering two doubles events, the player waives any right to minimum rest periods.
